

Beulah Park – \$1.00 Valentines’ Day Instant Bonus Day Promotion 2012 Official Rules

TO ENTER: Patrons must purchase a \$1 Valentines’ Day Instant ticket at Beulah Park from December 16th, 2011 through February 14th, 2012 ending at 4 PM. Contestants will receive a chance to win Ohio Lottery and Beulah Park prizes. Contestants shall drop their \$1.00 non-winning instant entry in the Register-To-Win box located within Beulah Park. Contestants must write their full name, address and phone on the entry. Entrants must be 18 years of age or older to be eligible. Illegible entries are void. No mechanically reproduced or photocopied entries permitted. Beulah Park, the Ohio Lottery Commission and their respective agents, employees, affiliates and subsidiaries are not responsible for illegible, lost, late, damaged, incomplete, entries. All materials submitted become the property of the Ohio Lottery Commission and Beulah Park (“Sponsors”) and will not be returned.

RANDOM DRAWING: Three (3) Prize Winners will be selected in a random drawing from among all eligible \$1.00 non-winning instant Valentines’ Day tickets received. A promotion hopper will contain all non-winning instant tickets. Three (3) separate tickets will be drawn from a hopper with the first drawing for a \$500.00 voucher; the second drawing for a \$200.00 voucher; and the third drawing for a \$100.00 voucher. The drawing will be held at 4:30 pm on February 14, 2012 with those winners’ names announced and shown on Beulah’s in house TV system. Winners need not be present to win and may only win once during this promotion. Winners will be notified via phone during the promotion will have **7 days** to claim their winnings. Winners must claim their prize at the Grandstand Guest Services Booth. Vouchers are redeemable at any Beulah teller window (no expiration period). An alternate will be chosen if the winner does not respond after the time allotted. Odds of winning will depend upon the number of eligible entries received. Prize is non-transferable.
