

Triple Crown Challenge  
2010 Official Rules

You must be 18 years of age or older to participate in the *Triple Crown Challenge* promotion. An entrant does not need to be present to win. Promotion winners will be selected in a random drawing on Saturday, April 17, 2010 (Kentucky Derby Winner) and Saturday, May 1, 2010 (Preakness and Belmont winners) of all available entries at the end of the respective racing days. Winner will be contacted personally by Beulah Park staff on Monday, April 19, 2010 and Monday, May 3, 2010. All winning entries will be subject to verification of eligibility. Any illegible entry shall be null and void. Only one prize per person is allowed. No substitution, transfer, cash redemption or assignment of prize permitted, except that Beulah Park reserves the right to substitute a prize of equivalent value or better in the event the offered prize is unavailable. To enter, fill out non-winning instant lottery tickets and place them in designated containers at Beulah Park from February 13 – May 1, 2010. No purchase is necessary.
