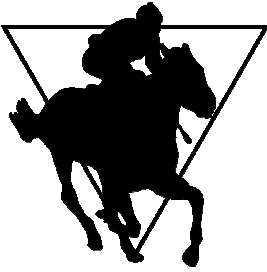

NOTICE TO HORSEMEN

Any horse who is not eligible to enter in another jurisdiction must obtain permission from the Board of Stewards before entering. There will be no exceptions to this rule.

-Per Order of the Board of Stewards

- No Pony with less than eight horses.
- Horses not raced for 60 days must have one published workout. Horses not raced for 90 days must have at least two published workouts.
- First time starters must have a minimum of three published works and be gate approved by the Starter.

EFFECTIVE IMMEDIATELY – Due to EPA and Dept. of Agriculture Regulations

- Only PHOSPHOROUS FREE Detergents are to be used
 - Manure MUST NOT be washed down drain REMOVE manure to Bins
 - LIMIT WASH TIME to Minimum necessary
 - SHUT OFF WATER WHEN NOT IN USE!!
- These Policies will be STRICTLY ENFORCED please cooperate

TERMS AND REGULATIONS FOR STALL APPLICATIONS:

PLEASE READ CAREFULLY

1. The terms of this contract shall be for the 2012 Winter/Spring race meeting of Beulah Park for the programs of thoroughbred racing beginning January 9, 2012
2. **The Applicant shall enter and race the horses listed hereon which have been assigned free stall space by Beulah Park in all races for which they qualify and are eligible unless the Racing Secretary shall agree otherwise.**
3. The Rules and Regulations of the Ohio State Racing Commission and rights of Beulah Park as a private enterprise shall govern the conduct of this meeting and racing programs and all the owners, trainers, jockeys and stable employees are subject to same.
4. Foal certificates must be filed at the Racing Secretary's office upon arrival and must be approved by the Racing Secretary.
5. Beulah Park reserves the right to reject any entry
6. All jockeys, trainers and exercise personnel are required to wear safety helmets and vests while riding or exercising horses according to the requirements of the Ohio State Racing Commission.
7. All changes in trainers must be reported to the Ohio State Racing Commission and the Racing Secretary immediately along with the owner's and previous trainer's authorization.
8. It is clearly understood and agreed that this is not a lease of any space, but is merely a revocable permit by Beulah Park only on the terms and conditions set forth.
9. Beulah Park may refuse admittance to or eject anyone with or without notice and with or without cause.
10. The applicant undertakes to keep the stabling accommodation and groom's quarters (including toilets) allotted to him in good and clean condition. The applicant consents to periodic inspection of such accommodation and quarters and any other facilities allotted to him by Beulah Park, including any property of others which may be located therein, at any times, with or without notice. Any damages to such accommodation and quarters will be repaired by Beulah Park, and the Applicant shall be responsible for the cost of such repairs.
11. The Applicant agrees to pay \$150.00 for each groom's room that he is allotted. Upon leaving, these rooms must be found suitable (empty and cleaned.)
12. Firearms are absolutely prohibited on the premises of Beulah Park
13. **Straw is the only bedding material permitted in the stable area.**
14. No dogs are allowed on the premises of Beulah Park
15. Heating appliances of any kind will not be allowed at Beulah Park. Cooking on the premises of Beulah Park is not permitted.
16. **All horses (including ponies) are required to have a negative Coggins Test certified, dated within the past 12 months.**
17. The parking of house trailers on the premises of Beulah Park is not permitted.
18. All owners, trainers, jockeys and their employees must obtain a license issued by the Ohio State Racing Commission before stable area passes admitting them to the stable will be issued by Beulah Park. Stable area passes may be used only by the person named upon the pass and misuse will be cause for revocation without notice. **All trainers and/or owners must have a Workman's Compensation policy covering all of their employees including exercise people and list number with Security.**
19. Horses (including Ponies) are required to have Health Certificated which must be presented at time of Arrival
20. Beulah Park may assign rooms to grooms and other stable employees as it deems fit. All the terms and conditions set forth in paragraphs 8, 9, 12 and 15 above as well as any other relevant provisions shall apply to the use of rooms by such persons.
21. Horses given permanent stalls should attempt to arrive between the hours of 8:00 a.m. and 4:00 p.m., when possible, to be able to be given their stalls and taken care of quickly as possible.
22. No privately owned hot walking machines will be permitted. Hot walking machine rentals must be worked out with the Stall Superintendent. **Daily maintenance of the walker area, to avoid flooding and freezing, is the responsibility of the renter.**
23. As used in the application, the term Beulah Park includes Beulah Park Gaming Ventures, Inc., and their respective partners, shareholders, directors, employees, and agents.
24. By signing below, the Applicant accepts and unconditionally agrees to all terms, covenants, and conditions on each side of this application, individually and on behalf of the owner(s) of any horse(s) in the care or custody of the Applicant. Applicant also agrees to all provisions of Beulah Park Horsemen's Guide which shall be made available to all applicants, and horsemen in general, prior to start of meet.

HOLD HARMLESS AGREEMENT

By stabling and/or racing at Beulah Park, Horsemen agree to fully exonerate, indemnify, defend and save harmless Beulah Park Gaming Ventures, Inc., its owners, agents and employees from and against all claims, actions, demands, losses and damages arising out of or resulting there from, and all expenses incidental to the defense of any such claims, actions, demands, losses and damages, including costs and attorney's fees, based upon or arising out of damage or injury to the Horsemen or other persons, including disability or death, or damage or injury to the property, including loss of use thereof, caused by or sustained in connection with the activities at Beulah Park in which Horsemen take part.
